January 7, 2020 Tuesday	<ul style="list-style-type: none"> <li>▪ First day that nomination petitions may be circulated prior to the regular election. <i>91 days 31-10-909(a)</i></li> </ul>
January 27, 2020 Monday	<ul style="list-style-type: none"> <li>▪ Last day that nomination petitions may be circulated, signed and filed with the municipal clerk. All petitions are considered valid unless the clerk receives objection by mail regarding the affected candidate. The clerk then has 48 hours upon receiving the objection to determine its validity. <i>71 days 31-10-909(a)</i></li> </ul>
February 3, 2020 Monday	<ul style="list-style-type: none"> <li>▪ Last day to amend (cure) defective petitions. <i>64 days 31-10-909(1)(a)</i></li> <li>▪ Last day for any person who has accepted a nomination to withdraw and submit a written affidavit stating so. <i>64 days 31-10-303</i></li> <li>▪ Last day that any petition or certificate of nomination to fill a vacancy in nominations must be filed with the Town Clerk. <i>64 days 31-10-304(1)</i></li> </ul>
March 16, 2020 Monday	<ul style="list-style-type: none"> <li>▪ Last day that a person can move into a municipal election precinct and become a resident for purposes of voting in the election. <i>22 days 31-10-201(1)(b)</i></li> <li>▪ First day a registered elector may file an affidavit of change of address within the municipality with the county clerk in order to vote at the new residence. An elector may file this affidavit on any day through Election Day. <i>22 days 31-10-208</i></li> </ul>
March 17, 2020 Tuesday	<ul style="list-style-type: none"> <li>▪ <b>Contribution report due to the Town Clerk.</b> <i>21 days 1-45-108(2)(a)(ii)</i></li> <li>▪ Last day for write-in candidates to file affidavit of intent with Town Clerk. <i>21 days 31-10-306</i></li> <li>▪ Frisco Candidate Forum – 6:30 pm Frisco Town Hall</li> </ul>
April 3, 2020 Friday	<ul style="list-style-type: none"> <li>▪ Last day to request “absentee ballot” (by 5:00 p.m.) <i>Friday before election 31-10-1002</i></li> <li>▪ <b>Contribution report due to the Town Clerk.</b> <i>Friday before election 1-45-108(2)(a)</i></li> </ul>
<b>April 7, 2020 Tuesday</b>	<ul style="list-style-type: none"> <li>▪ <b>Election Day – Mail-In Ballots may be dropped off at Town Hall from 7:00 a.m. – 7:00 p.m.</b></li> </ul>
April 17, 2020 Friday	<ul style="list-style-type: none"> <li>▪ Last day to request a recount of election results. <i>10 days 31-10-1207(2)</i></li> </ul>
April 22, 2020 Wednesday	<ul style="list-style-type: none"> <li>▪ Mandatory and optional recounts must be completed by this day. <i>15 days 31-10-1207 (1)</i></li> </ul>
April 28, 2020 Tuesday	<ul style="list-style-type: none"> <li>▪ Newly elected Council Members take Oath of Office.</li> </ul>
May 7, 2020 Thursday	<ul style="list-style-type: none"> <li>▪ <b>Final contribution reports form from candidates due in the Town Clerk’s office.</b> <i>30 days 1-45-108(2)(a)(ii)</i></li> </ul>
