

## Frisco Arts and Culture Council (FACC) Minutes

October 20, 2023 10:00am-11:30am in Frisco Town Hall in Council Chambers

- Approval of September 22, 2023 meeting minutes- approved unanimously
- FACC Updates
  - Silverthorne reached out for a joint meeting, and staff suggest a tour with Silverthorne Art Spot and their Art Commission- FACC suggested shooting for a Friday afternoon- staff to follow up with Silverthorne
  - Buskariachi- Daymon Pascual suggested ways to bring back music onto Main Street- provide wandering musicians to local restaurants and bring music onto Main Street- i.e. Silverheels, which used to do music, and maybe this would develop into a summer on the corner of each block festival. FACC did not direct staff to pursue this idea at this time.
  - o Do a pop-up art class that is very informal- "stitch and bitch", draw and sip, etc...
    - Directed staff to look at drawing- Focus on still life or figure (not nudes) drawing, beading, and textiles/knitting (knitting help- rather than even a full project)
    - FACC directed staff to come back with a budget for materials but would like to offer these pop-up classes for free.
    - Narrow the scope of any offerings
    - All ages welcome
    - Look at a storage space for donated art supplies
    - Staff to look at offering on Tuesdays or Wednesdays at the Frisco Adventure Park Day Lodge or the old community center on 3<sup>rd</sup> Avenue in 2024

## Staff updates

- Update on addition of art to environmental assessment for the Frisco Backyard plan- Council has approved a \$381,124 change order is requested to supplement the original \$240,500 contract. FACC asked that SE Group add artful signs and other elements to the plan and not expand the scope. Staff was directed to just bring a sentence to leadership to add into the plan, "Aspire to incorporate culture and art in trail signage, educational materials, monuments and other communication elements, where effective and technically possible."
- Update on workflow/project tracking- FACC asked staff to move forward with a Google spreadsheet- only staff will have editing rights due to open meeting laws.
- o Marina idea for pumpkin carving event in 2024- FACC voiced supportive and would like to be involved; are interested in possibly breaking a Guiness World Record.
- Public Art Assessment & Maintenance Plan Update

- o Option 2 timeline and progress- Initial cleaning and maintenance have been completed. Looking at replacing some missing components, ski poles and arrows, on two sculptures. They will supply a maintenance plan and repair plan in the upcoming months.
- Winter projects
  - Eat, Ski, Be Merry confirmed date is Saturday, February 3, 2024
    - Discuss Frozen Frisco vision- Determine a theme- lights and ice, campsite...
    - Set Frozen Frisco budget- include ice suppliers and locally commissioned pieces?
    - Have directed staff to come up with a plan
- Community Dinner Discussion- Move forward or table? FACC would like to have a meeting committed to this so the next meeting should be quick discussion of Frozen Frisco, mural locations, and then an extended discussion of the community dinner.
- Discussion of Arts and Culture Plan: Goal Two- Music Homebase. Make Music. This will need to be pushed to a future meeting.
- Moving to one meeting a month going forward- November 10 from 1:30-3:30pm
- Adjourn
