



Frisco Arts and Culture Council (FACC) Agenda
May 30, 2025, Meeting Minutes

- Roll Call

- Approval of April 18, 2025, Meeting Minutes- approved
- Member Updates
 - Jamie update- Gave an update regarding the Colorado Creative Industries Summit. Enjoyed seeing Grand Junction public art and commended the government and public support in Grand Junction. He made connections for music education that he will connect FACC with, as well as Fruita arts council members. Mentions that public art as a large statewide economic impact tool was highlighted during the conference. Recommends people attend next year if they can.
 - Melissa Update- Saw a project that put art on a chair lift and thinks there is potential in repeating this project with the old Lumberjack lifts being decommissioned from Copper Mountain. The FACC members who were present agreed that this would be a potential project. Melissa will reach out to people about getting a lift chair.
- Staff Updates
 - July 4 Stipends- FACC approved the four applicants. Melissa proposed a meeting between float applicants and an FACC representative to work on the art aspect, and the FACC members present seconded this. Council notes that these are more on the culture side of “arts and culture” and likes the community-based aspect rather than just marketing for the companies that applied.
 - Movie Night- Two crafts by Frosted Flamingo: the Claymation craft has been changed to Make a Tail craft, and dark sky pipe cleaner craft. Coloring sheets

have been added. AstroMark has confirmed he will be at the craft table. DJ Crisp has been confirmed for the event. Blu-ray of the movie will be rented from the Frisco branch of Summit County Library.

- Pacific Coast Cleaning- Conservators are coming out June 4-6. They will clean all public art and add new ski poles to Ski for Light and a new arrow to Repentance. They will prepare The Boss for moving. They have been in contact with Pat Milbery on the CDOT tunnel.
- RecPath Mural touchups- The FACC members present decided that touchups on existing rec path murals is a low priority, noting that they are still vibrant and the fading aspect is part of the aesthetic to the temporary murals on the RecPath and gave staff direction to not pursue touch up at this time. Mentions of only touching up murals the year after led to a conversation about making a longevity plan for murals.
- Walter Byron Mural- Blair met with Hilary and Susan, artists on this project. They have been connected with Pacific Coast to determine best practices on materials for the mural in order to ensure longevity of the mural. Public Works will powerwash the building before Hilary and Susan begin prep work.
- Wassail Mug- Review of the first round of designs. FACC members noted that the design looked more like a summer scene and that it appeared to be a grizzly bear in the mug design, rather than a black bear, which is native to Colorado. FACC directed staff to provide direction to the artist about focusing more on a winter imagery with a cozy cabin feel.
- Projects
 - RecPath murals- Three locations have been identified: top of the hill heading to the Adventure Park, near the Nordic Center, near the Marina entrance by the memorial bench. The price paid will be same as 2024, \$2,000 and an additional \$600 in supplies. Two members think in the future we will do new RFP for upcoming ones rather than picking from earlier applicants, but due to the timeframe they agree with using last year's mural applicants. The Council does not want a repeat artist for this year's murals from ones who painted 2024 murals. Council expresses timeliness as the top priority of this artist selection. A tally vote began to determine an approved artist list who would then be selected by the timeline they could complete the mural in.
- Adjourn- A council member lost zoom access, resulting in a loss of quorum. Mural artist selection was tabled, with co-chair suggesting a future meeting to pick artists.
