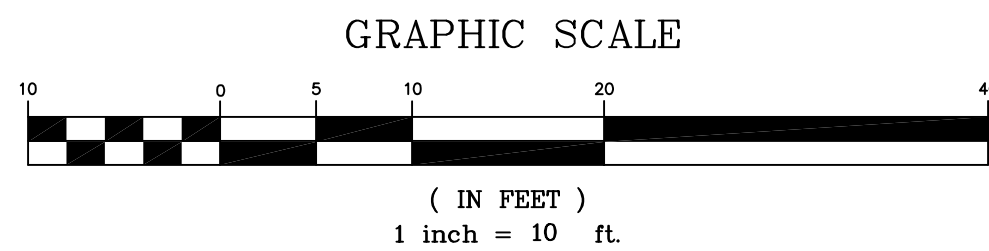
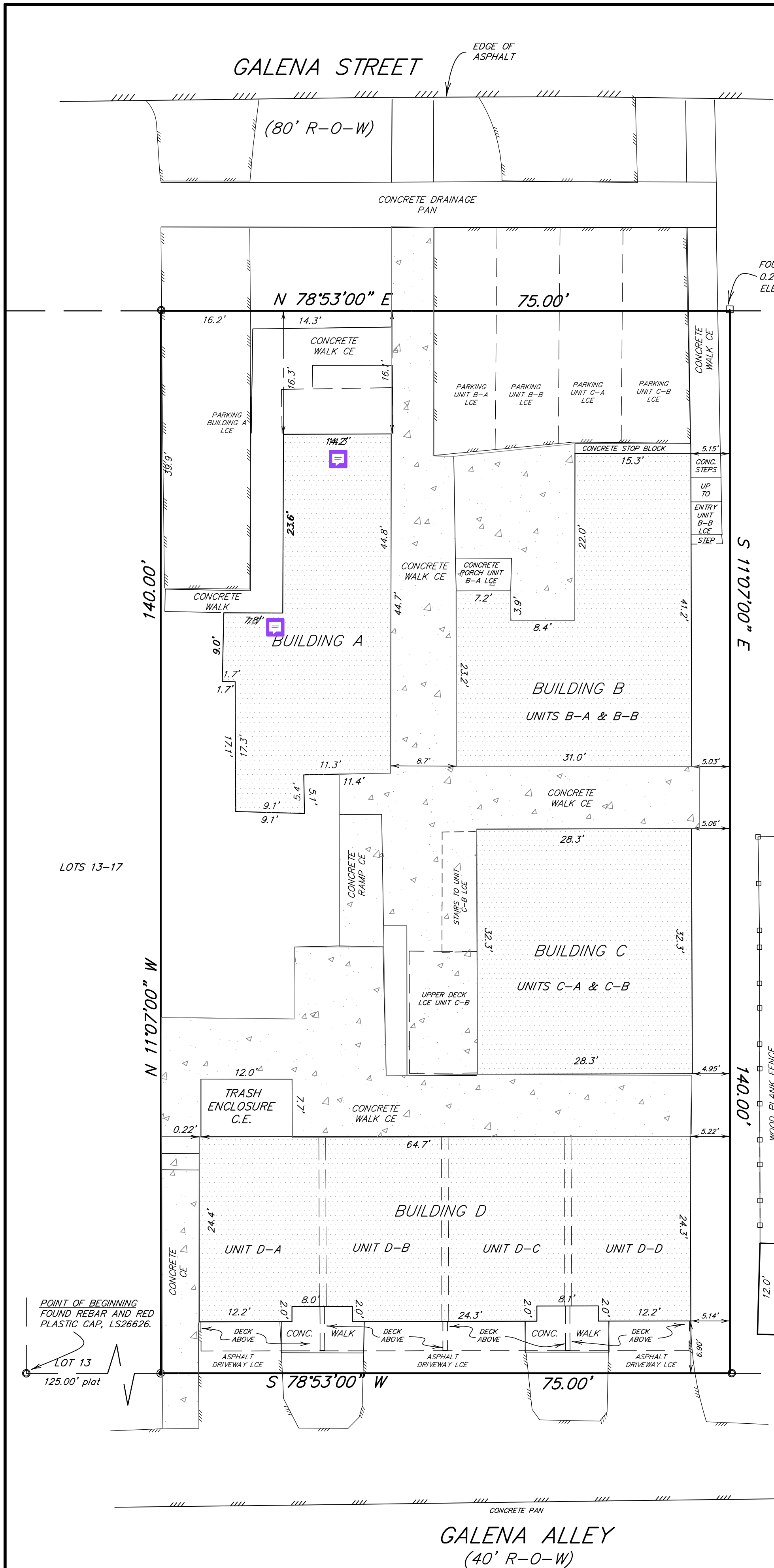


A CONDOMINIUM MAP OF
