



SUBMITTAL REQUIREMENTS: PERMIT TO EXCEED NOISE ORDINANCE LIMITS

General Explanation:

The Permit to Exceed Noise Ordinance Limits is submitted and circulated online to the Planning Division. Applications are administratively reviewed and approval is required. The application will be reviewed in accordance with the procedures and requirements as outlined in Section 2.5.2(C) of the Frisco Unified Development Code (UDC).

HOW TO APPLY FOR PERMIT:

1. Request your [CommunityCore](#) login: Email TOFPermits@townoffrisco.com with your name, email, phone number, and address. Community Development staff will send you an activation link that must be clicked within 5 days to set up your account. Once your account is set up, you can submit your planning application (see step 2).
2. Submit your planning permit application through [CommunityCore](#) and upload all pertinent documents in PDF format.

Community development staff will email you when fees are assessed.

Review the below submittal requirements for applicable plans and documents which shall be submitted online with the Permit to Exceed Noise Ordinance Limits application. Before submitting online, ensure you have all of the below information.

1. General Application Information

- ☐ Owner Name/Address
- ☐ Applicant Name/Address
- ☐ Description of Work/Request

2. Property Owner Consent

If the applicant is not the owner of the property, a written statement by the owner consenting to this application must be submitted.

3. Homeowners Association Consent

For any improvements proposed on the common area as defined by the homeowners association and/or the Community Development Department require written permission from the homeowners association to which the property is a member.

4. Application Fee: \$55.00

A non-refundable fee submitted with the application.

5. **Public Notice:** The applicant shall be responsible for providing accurate mailing labels within 300 Feet of property from the County Assessor's Office as part of the complete project application and shall bear all costs incurred in connection with giving notice of the public hearing. The Community Development Department shall be responsible for writing the content of notices and mailing. Please refer to Section 2.3.5 for additional information.

USE THE LIST BELOW AS A GUIDE OF ELEMENTS TO INCLUDE IN YOUR APPLICATION

Any person desiring to obtain a permit to exceed the noise levels designated in the Noise Ordinance (Frisco Town Code 127-53) may make an application online through CommunityCore to the town manager. The town manager shall have the authority to grant a permit to exceed the maximum permissible noise levels designated as shown in the chart below. Any permit granted by the town manager under this section shall be effective only for the location and times designated within the permit and shall be further subject to such conditions as may be set forth in such permit. In determining whether to grant a permit, the town manager shall give consideration to the following seven (7) criteria.

- ☐ Time of Day: _____ a.m./p.m. to _____ a.m./p.m.

- ☐ Duration of time: _____ Hours
- ☐ Loudness of proposed noise relative to the limits
- ☐ Potential impact of the noise to others in the vicinity of the noise source
- ☐ Sporadic or Continuous
- ☐ Extensiveness of the proposed noise
- ☐ Source of the noise and reason for need to exceed noise ordinance limits
